#### CITY COUNCIL MINUTES

### **NOVEMBER 2, 2015**

- 1. **Call to Order:** The regular City Council Meeting was called to order by Mayor Steve Kane at 6:00 pm.
- 2. **Roll Call:** Present were Mayor Steve Kane, Council members Richard Orpen, Rich Skordahl, Chris McClish and Tim Brown. Also present were City Engineer Jared Voge (Bolton & Menk, Inc.), City Attorney Scott Lepak (Barna, Guzy & Steffen), Public Works Director Paul Teicher, Police Chief Jeff Harapat, City Finance Director Darcy Mulvihill, City Administrator Joe Kohlmann, and City Clerk Barb Held.
- 3. Adopt Agenda: MOTION BY BROWN SECOND McCLISH TO ADOPT THE NOVEMBER 2, 2015 CITY COUNCIL AGENDA. Motion carried 5-0.

- 5. **Meeting Open to the Public:** Steve Feldman, 22766 Poppy Street, thank you to the City Council for the purchase of the new (electronic) speed sign. It is going to be a retraining. Only been there since Thursday, I know. Tagging people and the police presence is a good thing. I would also think a stop sign on 227<sup>th</sup> and 228<sup>th</sup> would make it more user friendly. I think the stop signs along with police presence will help with the speed.

Melissa Alm, 23909 Ute Street, questioning the order to stop work on a temporary building that is not on a slab. I didn't think you had to pull a permit. Other people have permanent structures and they did not have to pull a permit. Council suggested she discuss this the building official.

#### 6. **Petitions, Requests, Applications:**

a. Public Hearing: Certifying Assessments for Delinquent Utilities, Miscellaneous Invoices and Administrative Fines: Resolution 2015-60: Finance Director Darcy Mulvihill stated the property owners did receive notification of the delinquent bills and of this public hearing. Provided to the City Council was a list of utilities, miscellaneous invoices and administrative fines that are delinquent. Mayor Kane opened the public hearing at 6:06 pm for any public comment on the delinquent accounts. After no public comment, Mayor Kane

b. **PUD Amendment & Site Plan Review – St. Francis Transitional Care Facility – Resolution 2015-61:** Planner, Nate Sparks reported Able Companies, Inc. has submitted an application for a planned unit development amendment and building and site plan review for a transitional care and assisted living facility. The property is located at an unaddressed parcel on the north side of 229th Avenue NW in the 2900 block between the golf course clubhouse and the American Legion. This is part of The Ponds Golf Course PUD.

The applicant seeks to build a three-story facility with up to 40 assisted living, 34 memory care, and 15 transitional care units. Transitional care units are typically temporary lodging for patients before and after hospital stays. The facility will employ about 50-75 people. The Planning Commission recommended considered the request at their October meeting. They found that the flexibilities being requested to allow for a more residential/institutional style of architecture than that of a typical commercial building with a flat roof and block style construction were acceptable and met the City's PUD requirements. The Planning Commission recommended approval of the request with six conditions as noted in the proposed resolution. Sparks stated I could answer any questions you may have. Skordahl said the memorandum does outline what was discussed at the Planning Commission meeting. Kane stated he is excited for this type of facility in St. Francis. Police Dept: Electronic Speed Sign: Police Chief Jeff Harapat gave an update on the new electronic speed sign. The police department has placed the sign out on various streets. We have not had official training on all the options or data the sign can collect. We are getting some information off the machine. Pederson Drive we were logging over 1,000 vehicles a day. Last Wednesday, we did have some speeders on Poppy Street. Average speed in the 30 mph area was 25.06 mph. There were some 38, 37 and 33 mph in the numbers that were received. We will be doing a more detail traffic count and mph after our training. McClish asked if it does two way traffic? Harapat said we are not sure. Hopefully in the very near future we will have some more specific details.

City Administrator: Community/Economic Development Director Update: Kohlmann reported that Kate Thunstrom has passed all necessary backgrounds and has accepted a conditional employment offer for the Community/Economic Development Director position, contingent upon Council approval. Kohlmann is recommending to start Ms. Thunstrom at Grade 16, Step 6 of the City's 2015 salary schedule, vacation accrual 120 annually and starting with 40 hours of vacation and sick time. Kane said he may not be at the next meeting due to business conflict.
